- Navigating taxpayers with undisclosed foreign assets and accounts through the Offshore Voluntary Disclosure Program ("OVDP"), Streamlined Filing Compliance Procedures, and other avenues for getting into compliance.
- Successfully defending employers from employeeclassification audits.
- Obtaining innocent spouse and equitable relief for several taxpayers who had outstanding tax debts resulting from the misdeeds of their spouses.
